Preamble

WHEREAS it is expedient to promote sound learning in the Province of Otago in the Dominion of New Zealand and with that intent to establish and incorporate a University at Dunedin in the said Province of Otago open to all classes and denominations of Her Majesty's subjects.

1 Constitution of University

A University shall be established at Dunedin aforesaid and when duly constituted and appointed according to the provisions of this Ordinance shall be a body ... corporate by the name of the University of Otago and by that name shall have perpetual succession and shall adopt and have a common seal and shall by the same name sue and be sued, plead and be impleaded, answer and be answered unto in

all Courts of New Zealand, and shall be capable in law to receive, purchase, and hold all goods, chattels, and personal property whatsoever and shall also be able and capable in law to receive, purchase, and hold for ever not only such lands, buildings, hereditaments, and possessions as may from time to time be exclusively used and occupied by the said University for its immediate requirements but also any other lands, buildings, hereditaments, and possessions whatsoever situate in the said Province or elsewhere, and shall be able and capable in law to grant, demise, alienate, or otherwise dispose of all of any of the property, real, or personal, belonging to the said University, and also to do all other matters and things incidental or appertaining to a body corporate.
