An Act to repeal the Economic Stabilisation Act 1948 and to make provision incidental thereto

BE IT ENACTED by the Parliament of New Zealand as follows:

1 Short Title

This Act may be cited as the Economic Stabilisation Act Repeal Act 1987.

2 Repeals

The following enactments are hereby repealed, namely:

- (a) the Economic Stabilisation Act 1948;
- (b) the Economic Stabilisation Amendment Act 1968;
- (c) the Economic Stabilisation Amendment Act 1982;
- (d) Part 1 of the Finance Act 1983.

3 Consequential amendments and repeals

- (1) The enactment specified in Schedule 1 is hereby consequentially amended in the manner indicated in that Schedule.
 - (2) The enactments specified in Schedule 2 are hereby consequentially repealed.
