Immigration Amendment Regulations 2005: revoked, at 2 am on 29 November 2010, pursuant to section 405(b) of the Immigration Act 2009 (2009 No 51).

Pursuant to section 150 of the Immigration Act 1987, Her Excellency the Governor-General, acting on the advice and with the consent of the Executive Council, makes the following regulations.

**1 Title**

- (1) These regulations are the Immigration Amendment Regulations 2005.

## **2 Commencement**

These regulations come into force on 1 April 2005.

## **3 Schedule 1 amended**

Part 1 of Schedule 1 of the principal regulations is amended by inserting in clause B.1(b)(ii), in their appropriate alphabetical order, the items “Cyprus”, “Estonia”, “Latvia”, “Lithuania”, “Poland”, and “Slovak Republic”.

### **Explanatory note**

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 1 April 2005, amend the Immigration Regulations 1999 to add Cyprus, Estonia, Latvia, Lithuania, Poland, and the Slovak Republic to the list of countries whose citizens are exempt from the requirement to obtain a temporary visa for visits to New Zealand of 3 months or less.
