## Regulations

### 1 Title

These regulations are the Social Security (Income and Cash Assets Exemptions) Amendment Regulations (No 2) 2012.

### 2 Commencement

These regulations come into force on 1 April 2012.

These regulations amend the Social Security (Income and Cash Assets Exemptions) Regulations 2011 (the **principal regulations**).

### 6 Consequential revocation

Regulations 4 and 5 of the Social Security (Income and Cash Assets Exemptions) Amendment Regulations 2012 are consequentially revoked.
