## **Regulations**

### **1 Title**

These regulations are the Social Security (Exemptions under Section 105) Amendment Regulations (No 2) 2012.

### **2 Commencement**

These regulations come into force on 15 October 2012.

### **3 Principal regulations**

These regulations amend the Social Security (Exemptions under Section 105) Regulations 1998 (the **principal regulations**).

### **4 Regulation 3 amended (Exemption from obligations under section 60HA)**

In regulation 3(3)(c)(i), replace “6” with “5”.

### **5 New regulation 3A inserted (Exemption from obligations under section 60Q)**

After regulation 3, insert:

#### **3A Exemption from obligations under section 60Q**

- (1) A person to whom section 60Q of the Act applies may apply under section 105 of the Act to be exempted from some or all of his or her obligations under section 60Q, on a ground specified in subclause (2).

(2) A person described in subclause (1) may be granted an exemption from some or all of his or her obligations under section 60Q on the grounds that—

- (a) the person has recently changed his or her living circumstances because of family violence and needs time to adjust to the change; or
- (b) in the case of a person who falls within section 60Q(1)(a) or (b), the person needs time to adjust because—
  - (i) the person's spouse or partner has recently died; or
  - (ii) the person has recently separated from or ceased to live together with his or her spouse or partner; or
  - (iii) the person's de facto relationship has recently ended.

**6 Regulation 4 amended (Exemption from work test obligations: all work-tested beneficiaries)**

(1) In regulation 4(2)(f)(iv), after “a court”, insert “; or”.

(2) After regulation 4(2)(f), insert:

- (g) the person needs time to adjust because—
  - (i) the person's spouse or partner has recently died; or
  - (ii) the person has recently separated from or ceased to live together with his or her spouse or partner; or
  - (iii) the person's de facto relationship has recently ended.

**7 Regulation 5 amended (Exemption from work test obligations: work-tested spouses or partners)**

In regulation 5(2)(d)(i), replace “6” with “5”.

**8 Regulation 6 amended (Exemption from work test obligations: work-tested sole parents)**

(1) In the heading to regulation 6, after “parents”, insert “**and widows**”.

(2) After regulation 6(1), insert:

(1A) A work-tested widow's beneficiary may apply under section 105 of the Act to be exempted from some or all of her work test obligations on any of the following grounds:

- (a) any ground specified in regulation 4;
- (b) any ground specified in subclause (2);
- (c) any ground specified in regulation 7(2)(b) or (c).

(3) Revoke regulation 6(2)(b).

**9 Regulation 7 amended (Exemption from work test obligations: work-tested domestic purposes beneficiaries)**

In regulation 7(2)(c)(i), replace “6” with “5”.

**10 Regulation 8B replaced (Exemption from obligations under section 170: young parent payment recipients who have been married or in civil union or de facto relationship)**

Replace regulation 8B with:

**8B Exemption from obligations under section 170: youth support payment recipients who have been married or in civil union or de facto relationship**

- (1) This regulation applies to any young person who receives—
  - (a) a young parent payment because he or she meets the criterion in section 166(a) of the Act; or
  - (b) a youth payment.
- (2) Any young person to whom this regulation applies may apply under section 105 of the Act to be exempted from some or all of his or her obligations under section 170 on the ground that the person needs time to adjust because—
  - (a) the person's spouse or partner has recently died; or
  - (b) the person has recently separated from or ceased to live together with his or her spouse or partner; or
  - (c) the person's de facto relationship has recently ended.

### **Explanatory note**

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 15 October 2012, amend the Social Security (Exemptions under Section 105) Regulations 1998 (the **principal regulations**).

*Regulation 4* amends regulation 3 of the principal regulations so that a person who has primary responsibility for a child aged less than 5 years (rather than 6) may apply for an exemption under that regulation.

*Regulation 5* inserts a *new regulation 3A* of the principal regulations. This creates an exemption for certain persons who are subject to obligations under section 60Q of the Social Security Act 1964 (the **Act**), provided that one of the grounds in *new regulation 3A(2)* applies.

*Regulation 6* adds a new ground to regulation 4 of the principal regulations, which applies to all work-tested beneficiaries.

*Regulation 7* makes the same amendment to regulation 5 of the principal regulations as *regulation 4*.

*Regulation 8* amends regulation 6 of the principal regulations so that work-tested widow's beneficiaries may apply for an exemption from their work test obligations.

*Regulation 9* makes the same amendment to regulation 7 of the principal regulations as *regulation 4*.

*Regulation 10* replaces regulation 8B of the principal regulations. Under the substituted regulation, youth payment recipients will be entitled to apply for an exemption from their obligations under section 170 of the Act.
