Order

1 Title

This order is the Community Magistrates (Remuneration and Allowances) Amendment Order 2012.

2 Commencement

- (1) Clause 4 is deemed to have come into force on 10 October 2011.
- (2) The rest of this order comes into force on the day after the date of its notification in the *Gazette*.

3 Principal order

This order amends the Community Magistrates (Remuneration and Allowances) Order 1998 (the **principal order**).

4 Clause 2 replaced (Remuneration of Community Magistrates (other than Chief Community Magistrate))

Replace clause 2 with:

2 Remuneration of Community Magistrates (other than Chief Community Magistrate)

A Community Magistrate (other than the Chief Community Magistrate) is to be paid, for every day on which he or she attends the court in his or her capacity as a Community Magistrate, remuneration by way of a fee of \$13.60 for each quarter hour or part of a quarter hour, but no more than \$435 per day.

5 Order revoked

The Community Magistrates (Remuneration and Allowances) Amendment Order 2008 (SR 2008/225) is revoked.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order increases the fees payable to Community Magistrates other than the Chief Community Magistrate. *Clause 4* of this order, which provides for the increase in fees, is deemed to have come into force (retroactively) on 10 October 2011. The rest of this order comes into force on the day after the date of its notification in the *Gazette*.

At present Community Magistrates are paid \$12.50 for each quarter hour or part of a quarter hour attending court, but no more than \$400 per day.

The new remuneration rate for Community Magistrates is \$13.60 for each quarter hour or part of a quarter hour attending court, but no more than \$435 per day.
