Order

1 Title

This order is the United Nations Sanctions (Côte d'Ivoire) Regulations Revocation Order 2018.

2 Commencement

This order comes into force on 5 April 2018.

3 Revocation of United Nations Sanctions (Côte d'Ivoire) Regulations 2005

The United Nations Sanctions (Côte d'Ivoire) Regulations 2005 (SR 2005/339) are revoked.

4 Revocation of this order

This order is revoked on 3 May 2018.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 5 April 2018, revokes the United Nations Sanctions (Côte d'Ivoire) Regulations 2005 (and also the United Nations Sanctions (Côte d'Ivoire) Amendment Regulations 2008) because those regulations are no longer required. Those regulations gave effect to a number of sanctions imposed on Côte d'Ivoire by resolutions of the Security Council of the United Nations. This order gives effect to resolutions 2153 (2014) and 2283 (2016) of the Security Council, adopted pursuant to the United Nations Charter on 29 April 2014 and 28 April 2016 respectively.

Resolution 2153 lifts sanctions relating to the trade of diamonds from Côte d'Ivoire.

Resolution 2283 lifts the remaining sanctions, which relate to—

- the exportation of arms to Côte d'Ivoire and related activities, including the provision of military assistance, advice, and training; and
- the entry into New Zealand or transit through New Zealand of designated persons from Côte d'Ivoire; and
- dealing in money or other assets of designated persons from Côte d'Ivoire.

This order is revoked on 3 May 2018. Having done its work by that date, this order is spent and no longer needed in published form.
