## Order

### 1 Title

This order is the Tariff (Specified RCEP Parties) Order 2021.

### 2 Commencement

This order comes into force on 1 January 2022.

### 3 Specified RCEP parties

- (1) Each country listed in the Schedule is declared to be a specified RCEP party for the purposes of the Tariff Act 1988.
- (2) If a country is listed without a date next to it, the country is a specified RCEP party on and from the commencement date of this order.
- (3) If a country is listed with a date next to it, the country is a specified RCEP party on and from that date.

**Notes****1 General**
