2 Commencement of section 18 of COVID-19 Public Health Response Amendment Act 2021

Section 18 of the COVID-19 Public Health Response Amendment Act 2021 comes into force on 17 February 2022.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order brings section 18 of the COVID-19 Public Health Response Amendment Act 2021 (the **Act**) into force on 17 February 2022. The commencement of that section brings the **Act** fully into force.

Notes

1 General

This is a consolidation of the COVID-19 Public Health Response Amendment Act 2021 Commencement Order 2022 that incorporates the amendments made to the legislation so that it shows the law as at its stated date.

2 Legal status
