Explanatory note

This note is not part of the regulations but is intended to indicate their general effect.

These regulations, which come into force on 2 May 2025, amend the Passport (Fees) Regulations 2015 (the **principal regulations**).

The schedule of fees in the principal regulations is replaced with a new schedule that increases the fees payable in respect of passport and other travel document applications.
